Diocese of Jackson Demographics

Executive Summary

This report summarizes the overall demography of the Diocese of Jackson as well as a profile of the Catholic population living there. The data sources include the Decennial Census, The American Communities Survey (ACS) and other data sources from the Census Bureau. It also relies on the Pew Research Center's Religious Landscape Survey, and the Association of Statisticians of American Religious Bodies (ASARB) Decennial Religion Census.

Major Findings

- The total population of the Diocese is 2,138,154. This is expected to grow to 2,156,319 by 2030 and 2,141,320 in 2040.
- The median age in the Diocese is 40. About a quarter of the population are under the age of 18 (24%). Sixteen percent are age 65 or older. The total dependency ratio for the Diocese is 58.5. Thus, there are 58.5 individuals who are under 15 or 65 and older for every 100 individuals who are of "working age" between 15 and 64. For comparison, the total dependency ratio for the United States is 61.3.
- The school age population of the Diocese, those ages 5 to 24, is 589,400. If one assumes 4% are Catholic as in the Diocesan population as whole, there are 23,576 self-identified Catholic schoolage youth and young adults in the diocese. Or if use the Catholic parish-affiliated estimate of 2% then there are 11,788 active Catholic school-age youth and young adults in the Diocese.
- Ninety-eight percent of the residents of the Diocese self-identify as being of one race and 1.5% indicates they are of two or more races. Fifty-two percent of the population self-identifies as white. Forty-two percent self-identify as black or African American. One percent self-identifies as Asian. Three percent identifies a s Hispanic or Latino. Of the Hispanic population, 66% self-identify as Mexican, 6% as Puerto Rican, 3% as Cuban, and 25% as some other Hispanic or Latino nationality.
- There are 1,603,503 U.S. citizens ages 18 and older in the Diocese. This represents the voting
 age population (VAP). Forty-eight percent of this population is male and 52% is female. Two
 percent of the diocesan population were foreign-born.
- On average, 3% of households use a language other than English at home. By comparison, 22% of U.S. households use a language other than English at home. In the Diocese, Adams County has the highest percentage of 11%.
- There are 1,204,748 people in the diocese who are age 25 and older who are high school graduates. There are 342,246 people age 25 and older who have obtained their bachelor's degree. The maps below show differences in the percentage of those who are 25 and older who have obtained these by county.
- There are 430,007 persons living in poverty in the Diocese. This represents 20.1% of the population. By comparison, 11.5% of the U.S. population lives in property. The median

household income in the Diocese is \$40,808 per year. By comparison, this is \$69,021 in the United States.

- There are 968,823 housing units in the Diocese. Sixty-nine percent of these are occupied (compared to 64% in the U.S.). The median number of occupants per household is 2.61 (compared to 2.60 in the U.S.). Eighty-nine percent of the Diocese's residents live in the same household they did the year previous (compared to 87% in the U.S.). The median value of owner-occupied housing units in the Diocese is \$89,700. By comparison this 244,900 for the country. The median gross rent in the Diocese is \$658 per month. By comparison this is \$1,163 in the United States.
- Overall, 54% of women, ages 16 and older in the Diocese, are in the labor force (compared to 59% in the U.S.) as are 57% of all those age 16 and older (compared to 63% in the U.S.).
- The most comprehensive study with sufficient sample size to make estimates about religious affiliation and behavior is the Pew Religious Landscape Study (2014). In this survey, 4% of adult respondents living in a county within the Diocese self-identified as Catholic. This results in an estimated adult self-identified Catholic population of 65,114. If we assume minors affiliate with Catholicism at a similar rate that would add an additional 20,399 Catholics to the total population of the Diocese. Thus, survey-based estimates would assume that there are 85,513 Catholics in the Diocese of Jackson (4% of the population). The Diocese reported 42,850 Catholics in the 2021 Official Catholic Directory (2% of the population). These estimates tend to best approximate "parish-affiliated" Catholics. Thus, one can assume there are approximately 42,663 self-identified Catholics in the Diocese who are not attending Mass or active in a parish in any other way.
- If current trends continue, the Catholic adherent population of the Diocese is expected to grow to 53,799 in 2030 (2.5% of the population) and 55,849 in 2040 (2.6% of the population).
- The Diocese provided sacramental data for 2017-2018, 2019-2020, and 2020-2021. This time span includes shutdowns due to the COVID-19 pandemic in 2020 and 2021. This is evident in a steep decline in activity in 2020-2021. Prior to the pandemic, parishes in the Diocese reported an average of more than 43,000 Catholics in approximately 20,000 registered households. The average number of Baptisms was more than 700. The number of First Communions averaged more than 600 and there were typically nearly 500 Confirmations. There was also an average of more than 200 marriages per year and 400 funerals. During the height of the pandemic, there were more than 50% declines in all Sacraments with the exception of infant Baptisms and Confirmations, which each saw 39% declines.

Introduction


The Census profile is used for each county in the Diocese. These rely on different Census studies and reflect different times. The ACS public use microdata sample (PUMS). This source allows one to use the ACS as a survey looking at households and the individuals in them. This is a sample drawn from the full ACS with all identifiers removed. Results from the PUMS data do not always match the aggregate ACS or the decennial census. However, these are always very similar. Census 2020 data by county and ACS 2021 data by ZIP Code Tabulation Areas are utilized. The map below shows county names for the state.



Population Demographics


The total population of the Diocese is 2,138,154. Of this population, 1,036,396 are male (48.5%) and 1,101,758 are female (51.5%). There are 94 males per 100 females. There are more men than women in the following counties: Carroll, Grenada, Issaquena, Kemper, Leake, Sunflower, Tallahatchie, Wilkinson, and Yazoo. In all other counties and cities females outnumber males. The largest county, by population, is Hinds (227,742) followed by DeSoto (185,314), Rankin (157,031), and Madison (108,248). The smallest counties include: Issaquena (1,111), Sharkey (4,160), Quitman (6,327), and Jefferson (7,260). The maps below show variations in population size by county (left) and ZIP Code (right).






The State Data Center of Mississippi at the University of Mississippi report the 2020 population of the state was 3,066,382. This is expected to grow to 3,104,159 by 2030, then dip to 3,082567 in 2040, and decline again to 3,064,588 in 2050. Thus, between 2020 and 2050 the population of the state is expected to decline by 1,794 or 0.1%. If the Diocese's population trends mirror those of the state, the population of the Diocese of Jackson will be 2,156,319 in 2030, 2,141,320 in 2040, and 2,128,831 in 2050.






The median age in the Diocese is 40. About a quarter of the population are under the age of 18 (24%). Sixteen percent are age 65 or older. The total dependency ratio for the Diocese is 58.5. Thus, there are 58.5 individuals who are under 15 or 65 and older for every 100 individuals who are of "working age" between 15 and 64. For comparison, the total dependency ratio for the United States is 63.9.




The Diocese has more people of working age in its population and fewer dependents than the country as a whole. The youth dependency ratio for the Diocese of Jackson is 33.3 (i.e., those under age 15 per 100 people ages 15 to 64). In the United States this is 36.3. The senior dependency ratio for the Diocese of Jackson is 25.2 (i.e., those ages 65 and older per 100 people ages 15 to 64). In the United States this is 37.6. The largest segment of the Diocese's population is between the ages of 25 and 54 (37.6%). The maps that follow show the geographic distribution of older and younger populations by county and ZIP Code as well as median age.

Median Age






Population Under the Age of 18

The school age population of the Diocese, those ages 5 to 24, is 589,400. If one assumes 4% are Catholic as in the Diocesan population as whole, there are 23,576 self-identified Catholic school-age youth and young adults in the diocese. Or if use the Catholic parish-affiliated estimate of 2% then there are 11,788 active Catholic school-age youth and young adults in the Diocese. The National Catholic Educational Association (NCEA) reports a total of 2,466 students enrolled in the Diocese's Catholic primary schools and 893 in the Diocese's secondary schools in 2022-2023.


Race and Ethnicity



According to the General Social Survey (GSS) approximately 44% of Hispanic or Latino Catholics in the East South Central region of the United States (Kentucky, Tennessee, Mississippi, and Alabama) self-identified their religion as Catholic in the last decade. Thus, the Diocese likely includes approximately 26,000 Hispanic Catholics.




The largest number of black or African American residents are in Hinds County (167,940).




The largest number of Asian residents live in Madison County (2,904).




The largest number of American Indian or Alaska native residents live in County ().



The largest number of Hispanic or Latino residents live in DeSoto County (9,446).









Citizens Age 18 and Older






Foreign-born Population

Languages Other Than English Spoken at Home





Bachelor's Degree Completion Rate




Poverty and Income


There are 430,007 persons living in poverty in the Diocese. This represents 20.1% of the population. By comparison, 11.5% of the U.S. population lives in property. The median household income in the Diocese is \$40,808 per year. By comparison, this is \$69,021 in the United States.

The map below shows the geographic distribution of the poverty rate by county. The lowest poverty rates are in Rankin (10.8%) and the highest in Issaquena (43.9%). On the following page you see the geographic distribution of median household income by county. The highest median income of \$74,688 is in Madison County and the lowest of \$17,109 is in Issaquena.

Percentage in Poverty




Median Household Income




Housing

There are 968,823 housing units in the Diocese. Sixty-nine percent of these are occupied (compared to 64% in the U.S.). The median number of occupants per household is 2.61 (compared to 2.60 in the U.S.). Eighty-nine percent of the Diocese's residents live in the same household they did the year previous (compared to 87% in the U.S.). The median value of owner-occupied housing units in the Diocese is \$89,700. By comparison this 244,900 for the country. The median gross rent in the Diocese is \$658 per month. By comparison this is \$1,163 in the United States.

Median Gross Rent




Labor Force

Religious Affiliation

The Census does not, by law, collect information about religious affiliation. The most comprehensive study with sufficient sample size to make estimates about religious affiliation and behavior is the Pew Religious Landscape Study (2014). In this survey, 4% of adult respondents living in a county within the Diocese self-identified as Catholic. This results in an estimated adult self-identified Catholic population of 65,114. If we assume minors affiliate with Catholicism at a similar rate that would add an additional 20,399 Catholics to the total population of the Diocese. Thus, survey-based estimates would assume that there are 85,513 Catholics in the Diocese of Jackson (4% of the population). The Diocese reported 42,850 Catholics in the 2021 Official Catholic Directory (2% of the population). These estimates tend to best approximate "parish-affiliated" Catholics. Thus, one can assume there are approximately 42,663 self-identified Catholics in the Diocese who are not attending Mass or active in a parish in any other way.

The Glenmary Research Center has published a "Religion Census" since the 1950s. This is an attempt to rely on religious congregations to report their number of members to researchers. In combination with the U.S. Census, these researchers then make assumptions about the number of Americans who are "adherents" to a religion and those who are not. In considering the number of Catholics, adherents are best thought of as registered members of Catholic parishes. This excludes those who are participating in religious life but who are not registered (a growing population in recent decades —especially among foreign-born Catholics). It also excludes Catholics who are baptized and self-identify as Catholic but who are not participating in parish life (also a growing population in recent decades and now including a majority of self-identified Catholics). Counties without parishes do not include in adherents in the Religion Census. In reality, this of course is not the case.

If current trends continue, the Catholic adherent population of the Diocese is expected to grow to 53,799 in 2030 (2.5% of the population) and 55,849 in 2040 (2.6% of the population).

Catholic Population and Expected Population by County (Linear Estimates)

















CARA research indicates the Church returned to worship and sacramental practices similar to pre-COVID-19 levels in the Spring of 2023. Nationally, Mass attendance is still a two percentage points below pre-COVID-19 levels.
